

Health Update

Clinical error in obstetrical care is a serious problem that impacts families, healthcare providers, and others. These errors can lead to poor outcomes for patients and their babies, which is devastating for parents and other family members.

Henry County Health Center's Maternity Services Department is committed to providing the best outcomes for patients and babies. HCHC's participation in the **MOREOB** program (Managing Obstetrical Risk Efficiently) emphasizes safety by developing the knowledge, skills, attitudes, behaviors and practices that make patient safety the number one priority.

WHAT IS MOREOB?

MOREOB is a comprehensive, three-year, patient safety, professional development, and performance improvement program for caregivers and administrators in hospital obstetrics units. The program structure is based on the proven principles of High Reliability Organizations (HRO's) including: safety as the priority, effective

communication, teamwork, decreased hierarchy in emergencies, practice for emergencies, and reflective learning.

The program combines evidence-based professional practice standards and guidelines with current and evolving patient safety concepts, principles and tools. By learning and working together in their own practice environment, the healthcare team uses the shared knowledge, skills, attitudes and behaviors that contribute to safe, effective, patientcentered care in an efficient, collaborative, healthy practice environment.

"In my 30 years of obstetrical practice, I have been involved with many different obstetrical working environments. However, I have never experienced an obstetrical program, such as **MOREOB**, which so completely integrates all aspects of quality obstetrical care in one organized arena," commented Dr. Robert Smith, HCHC's Board Certified Obstetrician/ Gynecologist.

MOREOB at HCHC

The **MOREOB** Program has been delivered to HCHC on-site. A local Birthing Unit Core Team was trained by expert facilitators, and empowered by hospital administration, to lead all unit healthcare workers in the implementation of patient care and safety processes that are adapted to the unit's needs and practice environment. The Core Team consists of one family practice physician, one OB/GYN physician, the OB Supervisor and two front line staff nurses. This core team has met monthly to prepare for the program launch on September 30. HCHC's team will receive ongoing support through the services of **MOREOB** Program Consultants who are skilled in the program and available to respond to HCHC's needs in a timely manner.

The involvement of all front line professionals and all levels of hospital management leads to improved team performance, alignment of safety goals throughout the organization, and a fulfilling experience for all involved, including women and their babies. All OB delivering physicians and OB trained nurses are participating in this program. Learning together is essential to ensure that everyone has the same background knowledge and information to prepare to work more effectively as a team.

The **MOREOB** Program envisions a healthcare environment in which:

- Patient Safety is everyone's first priority
- There is trust and respect for all healthcare workers
- Effective communication is highly valued
- The model of care is focused on multidisciplinary collaboration and teamwork
- Reflective learning is an everyday practice
- Tacit and explicit knowledge is shared








At the end of March 2010, the newly renovated Infusion and Chemotherapy Department was open for service. Fortunately for patients in Southeast Iowa, they can now find medical oncology, infusion services, PET/CT imaging with additional x-ray services, laboratory testing and nutritional counseling — even therapeutic massage and tai chi classes — all at the same location. This centralization of services provides tremendous convenience for patients, whose course of daily treatment can last as long as eight weeks, and for family members or friends called upon to transport them to treatment. Frequently, patients requiring combination services can get testing and chemo-



therapy treatments in the same day, without having to make multiple trips.

The physicians and clinicians, along with caring administrative staff, support their patients in every way possible, putting their needs first. Even the physical appearance of the department was created with the human touch in mind. Comfortable treatment and waiting rooms put patients and their families at ease as soon as they walk through the doors. Upcoming Health Observances

October and November are designated months for Breast Cancer Awareness, Physical Therapy, and Diabetes Awareness. Henry County Health Center offers the following resources for area residents in these areas of healthcare:

IMAGING SERVICES

Breast Cancer Awareness Month emphasizes early detection as the best protection. HCHC's Imaging Services Department offers high quality digital mammography to meet the breast health needs of area women. HCHC undergoes annual state inspections by the Iowa Department of Public Health (IDPH), and receives excellent inspection ratings. All radiologists and technologists also meet all licensing and continuing education requirements annually. To schedule a mammogram, call your physician or Imaging Services at 319.385.6157. The American Cancer Society recommends yearly mammograms begin at age 40.

BREAST SURGERIES

Breast health services are also available through HCHC Surgery. Surgeries include breast biopsy, lumpectomy, mastectomy, sentinel lymph node biopsy, and axillary lymph node dissection. For more information about these breast procedures, contact General Surgeons Dr. Michelle Tansey at 319.385.6770 or Dr. Beth Hothan-Zielinksi at 319.385.6550. Clinical breast exams and monthly breast self-exams are also an important part of breast health.

BREAST CANCER TREATMENT

For patients in need of chemotherapy treatment for breast cancer, HCHC's Infusion/ Chemotherapy Department works with University of Iowa Oncology to provide chemotherapy close to home. Recent enhancements to the department ensure that more patients are able to receive treatments at HCHC with increased privacy and comfort amenities.

MammoSite 5-day Targeted Radiation Therapy is offered for breast cancer patients. Conventional radiation that takes six to seven weeks to complete, can be completed in five days. Dr. Tansey surgically implants and extracts the balloon at HCHC and the radiation therapy is inserted by a radiation oncologist.

DIABETES AWARENESS MONTH

provides opportunities to learn more about this disease that affects 23.6 million children and adults in the United States (7.8% of the population). HCHC's Diabetes Education Center is an important resource for people with diabetes and their families. Our diabetes team works with individuals to help them develop the skills, knowledge and attitude that allow them to live a full, flexible lifestyle while maintaining diabetes control. The Diabetes Program is State and Nationally Certified, and classes are presented by a variety of medical professionals. The Center offers a support group and several educational classes. PHYSICAL THERAPY MONTH:

HCHC's Rehabilitation Services Department provides excellent customer service and optimum patient care to lead our community in the promotion of health, wellness and fitness. A fully equipped gym and therapeutic pool on site allows us to provide convenient and high quality care for patients. Clinical staff consists of three physical therapists, three physical therapist assistants, an occupational therapist, speech therapist, massage therapist, two athletic trainers based at lowa Wesleyan College, and two support staff. Henry County Health Center Named 2010 Most Wired HCHC RECEIVES AWARD FOR FOURTH YEAR

Henry County Health Center has been recognized as one of the nation's "Top 100 Most Wired Hospitals" according to the results of the 2010 Most Wired Survey released in the July issue of *Hospitals & Health Networks* magazine. HCHC also received this award in 2007 and 2009, and in 2008 was named a "Top 25 Most Wired Small and Rural Hospital."

"This is a great honor for the organization, and was made possible through the commitment and dedication of our Medical Staff and associates," commented HCHC CEO Robb Gardner. "Our continual pursuit of excellence in information technology is ultimately for the benefit of our patients – to improve patient safety, and to provide high quality care in the most efficient way to give patients the healthcare experience that they expect and deserve." Dr. James Widmer, a member of HCHC's Medical Staff, agrees that being recognized for this award for a fourth year shows the importance that HCHC places on information technology's role in healthcare.

"This award is a positive reflection on how hard the hospital staff and physicians have worked to make advances in information technology for the benefit of our patients. This includes the implementation of electronic medical records, which is now federally mandated. This designation shows our commitment to increasing accessibility of medical information, and continuing the overall important emphasis on patient safety through tools like medication bar coding and computerized physician order entry," explained Dr. Widmer.

HCHC shows low rate of hospital acquired infections

Patient safety is top priority at Henry County Health Center, and this is obvious by HCHC's extremely low hospital acquired infection rate.

For the first six months of 2010, HCHC reported 0.3% hospital acquired infections, which equals four total infections. This number is impressive when compared to the much higher 4.5% national average. The national rate means that about 1.7 million people in the United States acquired a hospital infection last year, resulting in 99,000 deaths.

DEFINING HOSPITAL ACQUIRED INFECTIONS

Healthcare associated infections are infections that are not present, or without evidence of incubation, at the time of a patient's admission to a healthcare setting.

"This means that when a patient is admitted to the hospital with one

diagnosis, if after 48 hours of being admitted that patient develops an infection, then it is considered a hospital acquired infection. If a patient develops an infection within 30 days of discharge from the hospital, that infection is also considered hospital acquired," explained Cindy Cotton, HCHC's Infection Control Director.

INFECTION CAUSES& PREVENTION

Hospital acquired infections may occur if the patient's normal bacteria begins to acquire the characteristics of the bacteria around them. The most common hospital acquired infections are urinary tract infections, blood stream infections, pneumonia, and surgical site infections.

However, HCHC's impressive infection control numbers are attributed to medical staff and associates' diligence in adhering to policies and procedures that are designed to help prevent hospital acquired infections. HCHC follows these procedures to ensure infection control: hand hygiene, patient screening for MRSA, adherence to isolation precautions for specific diagnoses, mandatory vaccinations for hospital associates, collaboration between nursing and Environmental Services staff for appropriate cleaning of rooms.

"Our low hospital acquired infection rate demonstrates our commitment to patient safety and the delivery of high quality healthcare. We are dedicated to achieving our organizational mission of enhancing the health of individuals and our communities through high quality, effective and efficient services," explained Cotton.
